

**CAMP WASHINGTON CHILI CHEESE CONEY EATING CONTEST**  
Official Contest Rules

**Where:** Fountain Square in downtown Cincinnati, Ohio  
**When:** Friday, July 24, 2009, 12:30 – 1:00pm (contestants must arrive by 12:00pm)  
**Eligibility:** Contest is open to residents of Ohio, Indiana and Kentucky 18 years old or older.

**To Enter:** Carefully read the Official Rules and Entry Form, including the eligibility requirements and waiver of liability provisions. Twelve (12) winning entries will be randomly drawn. All winners must complete and sign the Waiver of Liability and Publicity. All forms become the property of Camp Washington Chili, Inc.

**Contest Rules:** Contestants will compete against each other in a timed event. The object of the competition is to eat as many Camp Washington Chili Cheese Conneys, without any condiments, as possible within the allotted time of 3 minutes. Any coney in a competitor's mouth at the whistle counts toward the final tally if the competitor chews and swallows that portion of the food. Separating the meat and bun to eat them individually is also allowed, but both items must be swallowed for credit. Contestants may drink water (provided) during the contest but may not dip coney or buns into water before consuming. Contestants must not touch any coney until the starting signal. Contestants must not touch any coney after the ending signal. Anyone violating these rules will be disqualified. Anyone suffering a vomiting incident before the time expires will also be disqualified.

Winner will be determined by counting the number of coney (all ingredients) eaten. The contestant consuming the most amount of coney when time has expired will win. Judges will be on hand to assure adherence to contest rules and to tally the number of coney eaten.

**Prize Awards:** One grand prize of a 2009 Camp Washington Chili Cheese Coney Eating Champion trophy, t-shirt, and hat as well as a \$50 Camp Washington Chili gift certificate will be awarded to a winner. Eleven runners-up will each receive a Camp Washington Chili t-shirt and hat. All contestants agree to the use of their name and likeness for advertising or trade purposes. Camp Washington Chili, Inc. reserves the right to cancel the event if a minimum number of participants are not met.

**Acknowledgment of Risks and Waiver of Liability:** Contestant acknowledges that there are risks of personal injury, illness and possible loss of life, and risks of damage to or loss of personal property, which may result from participating in this contest.
